| STUDENT<br>DISCIPLINE               | 5. The Board is not required to conduct an open meeting to deliberate in a case involving discipline of a public school child. <i>Gov't Code 551.082</i>   |
| EMPLOYEE-<br>EMPLOYEE<br>COMPLAINTS | 6. The Board is not required to conduct an open meeting to deliberate in a case in which a complaint or charge is brought against a District employee by another employee and the complaint or charge directly results in the need for a hearing. <i>Gov't Code 551.082</i>              |
| SECURITY DEVICES                    | 7. The Board is not required to conduct an open meeting to deliberate the deployment, or specific occasions for implementation, of security personnel or devices. <i>Gov't Code 551.076</i>  |
| ASSESSMENT<br>INSTRUMENTS           | 8. The Board shall conduct a closed meeting to discuss or adopt individual assessment instruments or assessment instrument items. <i>Education Code 39.030(a)</i>  |
